



Youth League Season Timeline - 2019

NOVEMBER:

1st November: Team affiliation opens

DECEMBER:

20th December: Closing Date for teams to register for 2018 season

JANUARY:

Wc 7th January: Scottish Women's Football (SWF) to forward list of affiliated teams to Regional League Administrator (RLAS)

Wc 7th January: Clubs to be asked if they are entering the Scottish Cup

19th January: SWF AGM

Wc 21st January: Regional League Management Committee (LMC) to meet to discuss & propose league compositions

Wc 21st January: RLAs to advise SWF and clubs on proposed league composition per region – **clubs have one week to appeal their placing**

25th January: Deadline for clubs to submit applications to register over/under-age players for 2019 season

FEBRUARY:

Wc 4th February: SQG Committee to meet and finalise/confirm league compositions & communicate to Policy Working Group (PWG) and Regional LMCs. SQG Committee to meet to review dispensation applications

Wc 4th February: Clubs advised of outcome of dispensation applications – **clubs have one week to appeal**

Wc 4th February: RLA's/SWF to schedule fixtures

Wc 11th February: SWF to review dispensation appeals & communicate outcome of appeals to clubs

15th February: Fixtures Announced

15th February: Deadline for Scottish Cup Applications

MARCH:

2nd/3rd March: League Starts

3rd March – 23rd June: 1st half of season (17 weeks) – league fixtures + cup/spare dates *TBC*

JUNE:

24th June – 11th August: Mid-season Break (7 weeks) *TBC*

24th June – 8th July: Mid-season window for clubs to submit applications to register over/under-age players for 2018 season.

JULY:

Wc 1st July: LMCs to meet to discuss and propose league compositions for second half of the season

Wc 8th July: RLA's to advise SWF and clubs on proposed league composition per region for second half of the season – **clubs have one week to appeal their placing**

Wc 15th July: SQG Committee to meet and agree leagues, considering any appeals from clubs, for second half of season & review any dispensation requests .Communicate final outcome to PWG and RLAs

Wc 22nd July: RLA's /SWF to announce fixtures for second half of season

Wc 22nd July: Clubs advised of outcome of dispensation applications

Wc 22nd July: Clubs will have one week following receipt of dispensation decision to appeal to SWF Board (£25 fee)

Wc 29th July: SWF to review dispensation appeals and communicate outcomes to clubs

AUGUST:

10th/11th August – 10th November: 2nd half of season (14 weeks) - league fixtures + cup/spare dates - TBC

31st August: Deadline for rule change submissions

SEPTEMBER:

Wc 30th Sept: Meeting dates & rule change proposals circulated to clubs/regions
