



Youth Timeline | Season 2020

NOVEMBER:

1st November: Team affiliation opens

DECEMBER:

20th December: Closing Date for teams to register for 2020 season

JANUARY:

W/c 6th January: Scottish Women's Football (SWF) to forward list of affiliated teams to Regional League Administrator (RLAS)

W/c 6th January: Application forms for Youth Scottish Cup sent out to clubs

W/c 20th January: Regional League Management Committees (LMC) to meet to discuss & propose league compositions

W/c 20th January: RLAs to advise SWF and clubs on proposed league composition per region – **clubs have one week to appeal their placing**

24th January: Deadline for clubs to submit applications to register over/under-age players for 2020 season

25th January: SWF AGM

FEBRUARY:

W/c 3rd February: SQG Committee to meet and finalise/confirm league compositions & communicate to Policy Working Group (PWG) and Regional LMCs. SQG Committee to meet to review dispensation applications

7th February: Clubs advised of outcome of dispensation applications – **clubs have one week to appeal**

W/c 10th February: SWF to schedule fixtures

14th February: SWF to review dispensation appeals & communicate outcome of appeals to clubs

17th February: Fixtures Announced
17th February: Deadline for Scottish Cup Applications

MARCH:

7th/8th March: League Starts
7th March –
27th June: 1st half of season (17 weeks) – league fixtures + cup/spare dates *TBC*

JUNE:

27th June –
15th August: Mid-season Break (7 weeks) *TBC*
26th June –
10th July: Mid-season window for clubs to submit applications to register over/under-age players for 2020 season.

JULY:

W/c 29th June: LMCs to meet to discuss and propose league compositions for second half of the season
W/c 6th July: RLA's to advise SWF and clubs on proposed league composition per region for second half of the season – **clubs have one week to appeal their placing**
W/c 13th July: SQG Committee to meet and agree leagues, considering any appeals from clubs, for second half of season & review any dispensation requests. Communicate final outcome to PWG and RLAs
W/c 20th July: SWF to announce fixtures for second half of season
W/c 20th July: Clubs advised of outcome of dispensation applications – 1 week appeal window starts (£25 fee)
W/c 27th July: SWF to review dispensation appeals and communicate outcomes to clubs

AUGUST:

8th/9th August –
8th November: 2nd half of season (14 weeks) - league fixtures + cup/spare dates - *TBC*
31st August: Deadline for rule change submissions

SEPTEMBER:

W/c 28th Sept: Meeting dates & rule change proposals circulated to clubs/regions
